I am following up on my telephone conversation of yesterday with Mr. Wester. Commission Staff needs the following information to complete its review of Muhlenberg County Water District's application:

- 1. How does Muhlenberg County WD currently read its meters?
- 2. What types of meters does Muhlenberg County Water District have (for example, displacement, multijet, compound, turbine)?
- 3. What is the age of Muhlenberg County WD's meters? Using the depreciation schedule provide in Muhlenberg County WD's last rate case proceeding, it appears that some meters have been in service for over 25 years, but the number of meters in service for that long is not discernible. Can Muhlenberg County provide the number of meters by the following age groups: 0-5 years, 6-10 years, 11-15 years, 16-20 years, over 20 years? (If specific numbers are not readily available, a rough estimate will suffice.)
- 4. If Muhlenberg County has perform any calculations of the cost savings that the meter replacement will achieve, please provide a copy.

A formal response to these questions is not require. A reply to this e-mail message is sufficient. I will ensure that the WD's responses are made a part of the case record.
