**SUBJECT:** April 29, 2013 Informal Conference ("IC")

An informal conference was held on April 29, 2013. The attendance sheet is attached to this memorandum. The purpose of the informal conference was to discuss the five month suspension of certain proposed Demand Side Management ("DSM") tariffs and the concern that any lengthy delay might negatively impact the programs.

The Residential Weatherization Program and the Residential and Commercial HVAC & Refrigeration Tune-Up Program were of particular concern to Big Rivers Electric Corporation ("Big Rivers") due to a desire to begin the weatherization in preparation for the heating season and the tuning-up of air-conditioning units in preparation of the summer cooling months.

Commission Staff requested that Big Rivers provide: (1) the proposed 2013 DSM budget by DSM program and (2) a copy of any third party contractor weatherization contracts. Big Rivers stated the responses will be filed by May 3, 2013.

There being no further discussions, the conference was adjourned.
