ORDER



The Commission, having considered Bullitt Utilities' motion, finds that the motion for a two-day extension to respond to Staff's First Request should be granted.

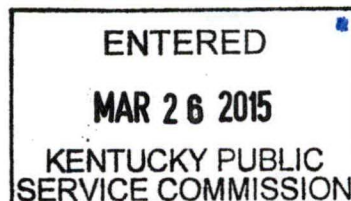
IT IS THEREFORE ORDERED that:
