ORDER

On March 20, 2015, Big Rivers Electric Corporation ("Big Rivers") tendered a motion to deviate from 807 KAR 5:001, Section 7, which requires the filing of a paper original and paper copies of all documents unless otherwise ordered by the Commission or electronic filing procedures are utilized.

In support of its motion, Big Rivers states that Kentucky Industrial Utility Customers, Inc.'s ("KIUC") First Request for Information ("First Request"), Items 2, 3.c., 4, 5, and 7, requests certain information in electronic format. Big Rivers further requests approval to submit its response to KIUC's First Request, Item 3.d., in electronic format due to the voluminous nature of the filing. It states that if printed, the response would be approximately 950 pages.

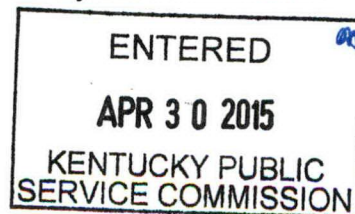
On April 14, 2015, Big Rivers tendered a second motion to deviate from 807 KAR 5:001, Section 7. Big Rivers states that KIUC requests the response to Item 1 of its First Request in electronic format.

The Commission finds that as KIUC requests responses to its First Request, Items 1, 2, 3.c., 4, 5, and 7, in electronic format, Big Rivers' request to deviate from the requirement to file an original and copies of those responses in paper medium should be granted. The Commission further finds that the response to KIUC's First Request, Item 3.d., is sufficiently voluminous to establish good cause to deviate from the requirement to provide ten paper copies of the requested information. However, the Commission finds that Big Rivers should file a single paper original of its response to KIUC's First Request, Item 3.d.

IT IS HEREBY ORDERED as follows:

1. Big Rivers' March 20, 2015 and April 14, 2015 motions to deviate are granted to the to the extent that Big Rivers may submit its responses to KIUC's First Request, Items 1, 2, 3.c., 4, 5, and 7, in electronic format.
2. Big Rivers shall file one original of its response to KIUC's First Request, Item 3.d., in paper format within seven days of the date of this Order's issuance.
