<u>order</u>

Western Pulaski County Water District ("Western Pulaski") has applied to the Commission for a Certificate of Public Convenience and Necessity ("CPCN") for a water system improvements project known as the "Phase 2 Project" and for an adjustment of rates.

Western Pulaski proposes to construct the Phase 2 Project, which consists of the construction and installation of approximately 22,860 linear feet of three-inch and four-inch polyvinyl chloride ("PVC") water line and appurtenances, and a new Supervisory Control and Data Acquisition ("SCADA") control system. This project will provide service to approximately ten new customers and will improve the quality of service to existing customers on Bridge Hollow Road, the Three Springs Area, Ferry Road, and Sleepy Hollow Road. The proposed project will also assist Western Pulaski, through a central SCADA unit, to oversee all water system activities at its remote sites, which are: seven storage tanks, six pump stations, and 11 master meters. The total cost of the project, including legal, engineering design, engineering inspection, and contingency fees, is \$1,120,000.

In Case No. 2012-00582,¹ the Commission granted Western Pulaski a CPCN to construct the Phase 1 Project, which consisted of constructing approximately 30,315 linear feet of three-inch polyvinyl chloride water line along the areas of Browns Ridge Road, Finley Owens Road, Hendricks Road, Shoreline Drive, and Hideaway Drive in western Pulaski County, Kentucky. The Commission also authorized Western Pulaski to issue \$1,400,000 of Waterworks Revenue Bonds to Rural Development ("RD"), an agency of the United States Department of Agriculture. In that proceeding RD explained that it would not authorize disbursement of any funds to Western Pulaski for the Phase 2 Project until this Commission issues a CPCN for that phase. Under the proposed rates, the monthly bill of a residential customer who uses 5,000 gallons of water will increase from \$31.80 to \$32.80, or approximately 3.14 percent.

Western Pulaski has submitted its application pursuant to KRS 278.023. Notwithstanding KRS 278.020(1), KRS 278.180, KRS 278.190, and KRS 278.300, KRS 278.023 requires the Commission to accept agreements between water districts and RD regarding construction projects, and to issue the necessary orders to implement the terms of such agreements within 30 days of satisfactory completion of the minimum filing requirements.

KRS 278.023 does not grant the Commission any discretionary authority to modify or reject any portion of the agreement between RD and Western Pulaski, or to defer the issuance of all necessary orders to implement the terms of that agreement. It

further denies the Commission any authority to reject an application when the evidence of record indicates that a water district's proposed facilities will result in the wasteful duplication of facilities or excessive investment or its proposed rates are unfair, unjust, or unreasonable.

Western Pulaski's application met the minimum filing requirements of KRS 278.023 on May 7, 2014.² The Commission, therefore, is not able to review this application using the same standards that are used for applications not filed pursuant to KRS 278.023.

IT IS THEREFORE ORDERED that:

1. Western Pulaski is granted a CPCN for the proposed construction project.

2. Western Pulaski shall obtain approval from the Commission prior to performing any additional construction not expressly authorized by this Order.

3. Notwithstanding ordering paragraph 2, if surplus funds remain after the approved construction has been completed, Western Pulaski may use such surplus to construct additional plant facilities if RD approves of the use and the additional construction will not result in a change in Western Pulaski's rates for service. Western Pulaski shall provide written notice of this additional construction in accordance with 807 KAR 5:069, Section 4.

4. Western Pulaski shall file a copy of the "as-built" drawings and a certified statement from the engineer that the construction has been satisfactorily completed in accordance with the contract plans and specifications within 60 days of substantial completion of the construction certified herein.

5. Western Pulaski shall require the construction to be inspected under the general supervision of a professional engineer with a Kentucky registration in civil or mechanical engineering to ensure that the construction work is done in accordance with the contract drawings and specifications and in conformance with the best practices of the construction trades involved in the project.

6. Western Pulaski shall notify the Commission in writing one week prior to the actual start of construction and at the 50 percent completion point.

7. The rates set forth in the Appendix to this Order are approved for service that Western Pulaski renders on and after the date of this Order.

8. Within 20 days of the date of this Order, Western Pulaski shall file revised tariff sheets with the Commission, using the Commission's electronic Tariff Filing System, containing the rates set forth in the Appendix to this Order.


