### AND

### MOTION TO SUSPEND RATES

Comes South Anderson Water District of Anderson County, Kentucky, P.O. Box 17, Lawrenceburg, Kentucky 40342, by counsel, and respectfully moves that it be granted leave to fully intervene in the captioned rate case, and moves that the rate increase be suspended pending a decision in this case. As grounds for this motion, South Anderson Water District states it purchases a significant portion of the water it purchases for resale to its customers from the Frankfort Electric and Water Plant Board ("Frankfort") and has recently completed construction of facilities with the intent to purchase a larger portion of the water in the future. The proposed rate increase, if granted, would significantly increase the water rates for the customers of South Anderson Water District and therefore South Anderson Water District respectfully requests full intervention in this case. South Anderson Water District believes its perspective as a wholesale customer of Frankfort will likely present issues and develop facts that will assist the Commission in fully considering the matter without unduly complicating or disrupting the proceeding.

South Anderson Water District further moves that the Commission suspend the effective date of the proposed rate increase pending a thorough examination by the Commission of whether Frankfort's proposed new rate is a fair, just and reasonable rate.
