ORDER

On April 21, 2015, East Kentucky Power Cooperative, Inc. ("EKPC") filed with the Commission its 2014 Integrated Resource Plan ("IRP"). Based on its initial review of EKPC's IRP, the Commission finds that additional inquiry is necessary.

IT IS THEREFORE ORDERED that:

1. The procedural schedule set forth in the Appendix to this Order shall be followed in this proceeding.

a. Responses to requests for information shall be appropriately bound, tabbed, and indexed and shall include the name of the witness responsible for responding to the questions related to the information provided, with copies to all parties of record, and the original and 10 copies to the Commission.

b. Each response shall be answered under oath or, for representatives of a public or private corporation or a partnership or association or a governmental agency, be accompanied by a signed certification of the preparer or person supervising the preparation of the response on behalf of the entity that the response is true and accurate to the best of that person's knowledge, information, and belief formed after a reasonable inquiry. c. EKPC shall make timely amendment to any prior response if it obtains information which indicates that the response was incorrect when made or, though correct when made, is now incorrect in any material respect.


d. For any request to which EKPC fails or refuses to furnish all or part of the requested information, it shall provide a written explanation of the specific grounds for its failure to completely and precisely respond.

e. A party filing a document containing personal information shall, in accordance with 807 KAR 5:001, Section 4(10), encrypt or redact the document so that personal information cannot be read.

2. Motions for extensions of time with respect to the schedule herein shall be made in writing and will be granted only upon a showing of good cause.

3. A person who submits a motion to intervene after July 16, 2015, and upon a showing of good cause is granted leave to intervene, shall accept and abide by the existing procedural schedule.
