ORDER

On October 21, 2010, in Case No. 2010-00116,¹ the Commission approved rates for Delta Natural Gas Company, Inc. (“Delta”) and provided for their further adjustment in accordance with Delta’s Gas Cost Adjustment clause.

On June 23, 2015, Delta filed its proposed Gas Cost Recovery (“GCR”) rate application to be effective July 27, 2015. Delta supplemented its GCR application on June 26, 2015.

After reviewing the record in this case and being otherwise sufficiently advised, the Commission finds that:

1. Delta’s notice includes revised rates designed to pass on to its customers its expected change in wholesale gas costs.
2. Delta’s notice sets out an Expected Gas Cost (“EGC”) of \$5.2204 per Mcf, which is a decrease of \$.2429 per Mcf from the previous EGC of \$5.4633 per Mcf.
3. Delta’s notice sets out no current quarter Refund Adjustment (“RA”). Delta’s total RA is \$.0000 per Mcf, which is no change from its previous total RA.

4. Delta's notice sets out a current quarter Actual Adjustment ("AA") of (\$.8764) per Mcf. Delta's total AA is \$.9591 per Mcf, which is a decrease of \$.7159 per Mcf from the previous total AA of \$1.6750 per Mcf.

5. Delta's notice sets out a current quarter Balance Adjustment ("BA") of (\$.0290) per Mcf. Delta's total BA is (\$.1358) per Mcf, which is an increase of \$.3063 per Mcf from the previous BA of (\$.4421) per Mcf.

6. Delta's GCR rate is \$6.0437 per Mcf, which is a decrease of \$.6525 per Mcf from the previous GCR rate of \$6.6962 per Mcf.

7. The rates as proposed by Delta and set forth in the Appendix to this Order are fair, just, and reasonable and should be approved for final meter readings by Delta on and after July 27, 2015.

IT IS THEREFORE ORDERED that:

1. Delta's proposed rates, as set forth in the Appendix to this Order, are approved for final meter readings on and after July 27, 2015.


