## NOTICE

On November 23, 2015, Pinewood Subdivision, Inc. ("Pinewood") submitted an application with the Kentucky Public Service Commission ("PSC") proposing to transfer its assets to Western Mason Sanitation District ("Western Mason"). Once the transfer is complete, if approved, Pinewood customers will be charged the same rates as Western Mason's customers. The rate impact of the proposed transfer is as follows:

Monthly Service Charge: \$22.05	Minimum Bill (2,000 gallons): \$41.31	\$19.26

Returned Check Charge: \$25	\$30	\$5
Late Payment Penalty: 10%	10%	N/A
Non-payment disconnect: N/A	\$75	\$75

The bill for an average customer using 3,000 gallons of water each month would increase \$28.67 per month, from \$22.05 to \$50.72 or 130%.

The PSC has up to 120 days from the date the application was filed to issue a final decision in this matter.

Any person may also examine this filing at the PSC located at 211 Sower Boulevard in Frankfort, Kentucky, Monday through Friday from 8:00am to 4:30pm or through the PSC website at <http://psc.ky.gov>.

Comments regarding the filing may be submitted to the PSC through its website or by mail to Public Service Commission, Post Office Box 615, Frankfort, KY 40602.

Any person may submit a timely written request for intervention to the PSC which establishes the grounds for the request including the status and interest of the party.

If the PSC does not receive a written request for intervention within thirty (30) days of the date notice was initially provided, the PSC may take final action on the filing.
