My family and I live in the Hode area of Martin County. As of January 8, 2018 our water pressure became very low. Today, January 9th we received an automated call around 3:30 p.m. from the Martin County Water District (I was still at work when I received this call) informing us that our water would be shut off from 3 p.m. - 5 a.m. until further notice. My husband and I both work and aren't even home at this time, therefore making it impossible to get a shower, cook dinner, do dishes, etc. without purchasing water. And my husband leaves in the a.m. before the water is back on. (They will not be supplying us with water.) Yet all customers in the Inez area will not have to experience any water loss whatsoever. And to add insult to injury they're proposing a 50% rate increase. Please tell me how this is fair when the water isn't even safe to use when it is on. It was told years ago when we had issues that the Warfield side of the county could receive water from Kermit, WV but was refused. We would greatly appreciate any help you could give in this matter.

We as citizens of the county and consumers of the water are very concerned. The water company has not been in compliance for years. We have had issues from the time (approximately 30+ years) we paid to tap into the city water. For years our lines have stopped up with sand and debris. Most of the time this happened when the water was shut off and turned back on to us. This has happened countless times. We have purchased numerous regulators because of this problem. We have had our water turned off many, many, times without any warning. As we are writing this, our water is being turned off at 3:00 p.m. to 5 a.m. each day, along with a boil water advisory. We were given notice of this occurrence. We have purchased drinking, cooking, coffee, and water for brushing teeth for as long as we can remember. We have had brown water, white milky water, and stinking water during these years. Our biggest concern is our health and our son's health (raised with this water), due to the cancer causing agent or agents found in our water supply. We have never felt secure using this water. Please consider the welfare of the consumer during this investigation. Why should we pay for a service that is dangerous to our health? If you could help our county with this water crisis, we would sincerely appreciate it.
