ORDER

On June 16, 2016, Airview Utilities, LLC ("Airview") tendered a notice of surrender and abandonment of utility property ("Notice") stating its intent to abandon all the property interests and rights in and to the property owned by Airview necessary to provide service to its customers. On July 8, 2016, the Attorney General ("AG") filed a motion to intervene, and on July 12, 2016, the Commission granted him intervention into the case. After Airview cured a deficiency in its Notice, it was accepted for filing as of July 11, 2016.

On July 29, 2016, the Commission entered an Order that, among other things, initiated an investigation into the request by Airview to abandon its utility services and facilities and ordered Airview to file responses to information requested in the Appendix of that Order.¹ On August 11, 2016, upon Airview's motion for an extension of time, the Commission entered an Order that required Airview to file its responses to the information requested in the Appendix of our July 29, 2016 Order on or before August 22, 2016.

On August 16, 2016, the AG filed his initial request for information ("AG's Initial Request"). The Commission, on its own motion, finds that Airview should

file its responses to the AG's Initial Request no later than 14 days from the date of this Order. The Commission further finds that a hearing on this matter should be held on October 12, 2016, at the Commission's Offices at 9:00 a.m. Eastern Daylight Time.

IT IS THEREFORE ORDERED that:

1. Airview shall file its responses to the AG's Initial Request on or before 14 days from the date of this Order.

2. Supplemental requests for information to Airview shall be filed no later than September 26, 2016.

3. Airview shall file its responses to supplemental requests for information no later than October 6, 2016.

4. A formal hearing in this matter shall be held on October 12, 2016, at 9:00 a.m. Eastern Daylight Time, in the Commission's offices at 211 Sower Boulevard, Frankfort, Kentucky.

5. Airview shall appear at the formal hearing scheduled on October 12, 2016.

6. The October 12, 2016 hearing shall be recorded by videotape only.

7. Pursuant to 807 KAR 5:001, Section 9(3), Airview shall serve notice of the hearing's purpose, time, place, and date to its customers no less than 14 days nor more than 21 days prior to the hearing. Airview shall provide a copy of the notice to the Commission on or before the date of the hearing.

8. The Commission shall serve a copy of this Order to the Kentucky Division of Water; the Hardin County Judge/Executive; the Mayor of the city of Elizabethtown, Kentucky; the Department of Planning and Development of the city of Elizabethtown; the Hardin County Planning and Development Commission; the Department of Water.

and Wastewater of the city of Elizabethtown; Hardin County Water District No. 1; Hardin County Water District No. 2; and the Lincoln Trail District Health Department.
