COMMISSION STAFF'S THIRD REQUEST
FOR INFORMATION TO THE CITY OF ELIZABETHTOWN

The city of Elizabethtown (Elizabethtown), pursuant to 807 KAR 5:001, is to file with the Commission the original and six copies in paper medium of the following information. The information requested herein is due on September 13, 2018. Responses to requests for information in paper medium shall be appropriately bound, tabbed, and indexed. Electronic documents shall be in portable document format (PDF), shall be searchable and shall be appropriately bookmarked.

Each response shall include the name of the witness responsible for responding to the questions related to the information provided. Each response shall be answered under oath or, for representatives of a public or private corporation or a partnership or association or a governmental agency, be accompanied by a signed certification of the preparer or the person supervising the preparation of the response on behalf of the entity that the response is true and accurate to the best of that person's knowledge, information, and belief formed after a reasonable inquiry.

Elizabethtown shall make timely amendment to any prior response if Elizabethtown obtains information that indicates that the response was incorrect when made or, though correct when made, is now incorrect in any material respect. For any request to which Elizabethtown fails or refuses to furnish all or part of the requested

information, Elizabethtown shall provide a written explanation of the specific grounds for its failure to completely and precisely respond.

Careful attention shall be given to copied material to ensure that it is legible. When the requested information has been previously provided in this proceeding in the requested format, reference may be made to the specific location of that information in responding to this request. When applicable, the requested information shall be separately provided for total company operations and jurisdictional operations. When filing a paper containing personal information, Elizabethtown shall, in accordance with 807 KAR 5:001, Section 4(10), encrypt or redact the paper so that personal information cannot be read.

1. Provide an update to the negotiations between Elizabethtown and Airview Utilities, LLC (Airview), on the division of costs related to the interconnection between the Airview system and the Elizabethtown wastewater system.

2. Provide any engineering reports or studies that Elizabethtown has commissioned or taken possession of regarding the interconnection between Airview's system and the Elizabethtown wastewater system.
