In compliance with the Order entered August 14, 2019 ("the 8/14/19 Order"), ordering ¶3, Bluegrass Water Utility Operating Company, LLC ("Bluegrass") hereby notifies the Commission in writing of the occurrence date for an asset-transfer approved in the 8/14/19 Order. On September 19, 2019, the acquisition/transfer transaction closed with respect to the assets of:

### Airview Utilities, LLC

As agreed by the transaction parties in an amendment to the Agreement for Sale of Utility, Bluegrass Water paid a purchase price for the acquisition of the Airview assets that complied with Condition # 15 of the 8/14/19 Order.

In the light of the pending proceeding in which Airview requested Commission permission to abandon the system, Case No. 2016-00207, Bluegrass makes the following statements:

(1) at the closing of the transaction, Bluegrass assumed responsibility for the operation of the system and became the jurisdictional utility with respect to the sewage service formerly provided by Airview; and (2) since the closing, Bluegrass has provided continuity of sewage service to the

customers formerly served by Airview. In addition, and in compliance with KRS 278.160(1), 807 KAR 5:011, and Condition # 18, Bluegrass will file an adoption notice for Airview's tariff within 30 days of September 19, 2019, and will thereafter file a tariff in its own name with respect to the Airview system.
