

MOTION OF CITY OF HENDERSON, KENTUCKY, AND
HENDERSON UTILITY COMMISSION,
d/b/a HENDERSON MUNICIPAL POWER & LIGHT,
FOR A BRIEFING SCHEDULE

The City of Henderson, Kentucky, and the Henderson Utility Commission, d/b/a Henderson Municipal Power & Light (jointly referenced hereinafter as "Henderson"), by counsel, move for an order setting forth a briefing schedule for the submission of simultaneous briefs and simultaneous replies.

The Commission issued a procedural order on August 15, 2016. All scheduled steps in the order have been completed. That order referenced the possible scheduling of a hearing and briefs. Henderson moves for a briefing schedule to allow the parties to address all issues raised in the pleadings and discovery. Additionally, Henderson asserts that there exist significant legal questions regarding Commission jurisdiction to preside over this dispute. To resolve the legal questions and avoid an unnecessary hearing, the parties should be afforded an opportunity to fully brief those issues.
