ORDER

On January 19, 2017, Janice M. Theriot, an attorney licensed to practice law in the Commonwealth of Kentucky who is representing the Kentucky Cable Telecommunications Association ("KCTA"), moved the Commission to admit, *pro hac vice*, Gardner Gillespie, Paul Werner, and Megan Grant, attorneys whose offices are in Washington, D.C., to practice law before the Commission on behalf of KCTA in this case. In support of the request, Mr. Gillespie, Mr. Werner, and Ms. Grant have shown that they are members in good standing of another state bar and have been certified to practice before the Commission in this case by the Kentucky Bar Association under Supreme Court Rule 3.030(2). 1. Gardner Gillespie, Paul Werner, and Megan Grant are admitted, *pro hac vice*, for the purpose of representing KCTA in the above-styled proceeding, provided

that Janice M. Theriot or another member of the Kentucky Bar Association acts as co-counsel and is present at any and all proceedings before this Commission.

2. KCTA's request to substitute Megan Grant as counsel for KCTA in place of Carrie Ross is granted.
