COMMISSION STAFF'S SECOND POST-HEARING REQUEST FOR INFORMATION  
TO KENTUCKY UTILITIES COMPANY AND LOUISVILLE GAS AND ELECTRIC  
COMPANY

Kentucky Utilities Company ("KU") and Louisville Gas and Electric Company ("LG&E") (jointly, "KU/LG&E"), pursuant to 807 KAR 5:001, are to file with the Commission the original with six copies in paper medium and an electronic version of the following information. The information requested herein is due on or before June 9, 2017. Responses to requests for information shall be appropriately bound, tabbed and indexed. Each response shall include the name of the witness responsible for responding to the questions related to the information provided.

Each response shall be answered under oath or, for representatives of a public or private corporation or a partnership or association or a governmental agency, be accompanied by a signed certification of the preparer or the person supervising the preparation of the response on behalf of the entity that the response is true and

accurate to the best of that person's knowledge, information, and belief formed after a reasonable inquiry.

KU/LG&E shall make timely amendment to any prior response if they obtain information which indicates that the response was incorrect when made or, though correct when made, is now incorrect in any material respect. For any request to which KU/LG&E fail or refuse to furnish all or part of the requested information, they shall provide a written explanation of the specific grounds for their failure to completely and precisely respond.


Careful attention shall be given to copied material to ensure that it is legible. When the requested information has been previously provided in this proceeding in the requested format, reference may be made to the specific location of that information in responding to this request. When filing a paper containing personal information, KU/LG&E shall, in accordance with 807 KAR 5:001, Section 4(10), encrypt or redact the paper so that personal information cannot be read.

Provide a schedule that lists by entity – LG&E Gas, LG&E Electric and KU jurisdictional – all 2016 Company 401(k) match costs for employees who participated in both the Retirement Plan (eligible if hired prior to 1/1/06) and the 401(k) Company Match, segregated by employee category: Bargaining Unit, Exempt, Hourly, Manager, Non-Exempt, Officer & Director, 99 (LTD) and All Salary Admin Plans. If there are allocated costs associated with employees from LKS that are included in any of the entities identified above, identify those costs by

employee category and the amounts allocated to each entity. Use the following format to provide the requested information.
