MOTION FOR EXPEDITED APPROVAL

Pursuant to Section 252(e)(1) of the Telecommunications Act of 1996 (the "Act"), 47 U.S.C. 252 (e)(1), Cellular Services, LLC¹ ("CLEC"), through its undersigned counsel, hereby requests expedited approval of its adoption of a negotiated interconnection agreement between AT&T Kentucky ("ATT") and CLEC.

CLEC is a utility within the meaning of KRS 278.010(3)(e) and is a competitive local exchange carrier authorized to provide service in Kentucky. ATT is an incumbent local exchange carrier or ILEC.

Pursuant to Section 252 (i) of the Act, CLEC adopted the terms of the Interconnection Agreement ("Adoption") between ATT and Peoples Telecom, LLC ("PTC") that was approved by the Kentucky Public Service Commission as an effective Agreement (the "Agreement") in the Commonwealth of Kentucky. That agreement was filed under PSC Reference No. 01166 and became effective on October 6, 2016.

CLEC's Adoption was filed by ATT on November 2, 2016 (PSC Reference Number yet to be assigned). Absent affirmative Commission action the Adoption becomes "approved" only by operation of federal law, after the 90 day period described in Section 252(e)(4) of the Act. Accordingly, the Agreement would not become effective until January 31, 2017. CLEC intends to operate using the Agreement as soon as possible and further delay will impede its business plans. With this application, CLEC requests that the Commission issue an order approving the negotiated agreement. Such order will expedite CLEC's expansion in the Kentucky market.

WHEREFORE, CLEC respectfully requests that the Commission issue an order on an expedited basis approving the agreement.

¹ As a point of clarification, Cellular Services, LLC is a facilities-based carrier and is not operating as a wireless provider in this matter as its name might otherwise suggest.
