ORDER

A hearing on the alleged failure of Louisville Gas & Electric Company to comply with KRS 278.495, 807 KAR 5:022 and 49 CFR 192 was held at the offices of the Public Service Commission at 211 Sower Boulevard, Frankfort, Kentucky, on Wednesday, November 7, 2017, at 8:30 o'clock a.m. At the conclusion of the witness testimony, staff counsel advised that he wished to file post hearing data requests and counsel for Louisville Gas & Electric advised that he would like to file a post hearing brief after the response to data requests had been filed.

IT IS THEREFORE ORDERED that:

1. Post hearing data requests, if any, shall be filed on or before Wednesday, November 15, 2017.
2. Responses to post hearing data requests shall be filed on or before Wednesday, November 22, 2017.
3. Counsel for Louisville Gas & Electric shall file a memorandum brief in support of his client's post hearing position on or before Friday, December 22, 2017.

Counsel for staff, if desired, may, but is not required to file a memorandum brief in support of staff's position on or before December 22, 2017.

This case shall stand submitted for a decision by the Commission effective 12:01 a.m., December 23, 2017.
