ORDER

On its own motion, the Commission finds that the post-hearing brief tendered for filing by Defendant, Basil C. Pollitt, d/b/a The Gas Group, Inc. a/k/a The Gas Group, on September 22, 2017, is rejected as untimely filed.

At the conclusion of the August 9, 2017 hearing, counsel for Mr. Pollitt stated that he would file a post-hearing brief. Counsel for Mr. Pollitt agreed that he would have sufficient time if the post-hearing briefs were due on September 8, 2017.¹ From the bench, the Commission established September 8, 2017, as the deadline for filing post-hearing briefs.²

Mr. Pollitt did not file a motion for an extension of time to file his post-hearing brief on or before September 8, 2017. Mr. Pollitt did not tender a motion for leave to file

an untimely brief when he tendered his brief. Mr. Pollitt did not set forth any reason, much less good cause, for tendering his untimely brief.
