ORDER

On June 23, 2017, Big Sandy Rural Cooperative Corporation (“Big Sandy”) filed a motion requesting that the Commission issue an Order 1) permitting Big Sandy to withdraw its Application filed on June 2, 2017, and 2) dismissing the above-styled proceeding without prejudice. Stating that it needs additional time to develop its proposed rate adjustment, and citing the prudence of pursuing these matters outside the pending rate adjustment proceeding’s statutory and procedural deadlines as the basis for the motion, Big Sandy argues that granting its request will advance the interests of administrative economy and yield just and reasonable results.

Having reviewed the motion and being otherwise sufficiently advised, the Commission finds that Big Sandy has established good cause to grant the request to withdraw its Application and dismiss the above-styled proceeding without prejudice.

IT IS THEREFORE ORDERED that:

1. Big Sandy’s motion to withdraw its Application filed on June 2, 2017, is granted.
2. All other pending motions in this matter are denied as moot.
3. The above-styled proceeding is dismissed without prejudice.

4. In the event that Big Sandy files another rate application, it shall file a new notice of intent pursuant to 807 KAR 5:001, Section 16(2).

5. This case is closed and removed from the Commission's docket.
