ORDER


On March 30, 2018, the Commission entered an Order in this matter approving new water service rates and sewer service rates for the Symsonia Water District and Sewer District ("Symsonia District"). However, the Appendix to the March 30, 2018 Order inadvertently referenced the wrong case number and the last rate step for the 5/8" x 3/4" Meter was stated incorrectly.

Therefore, the Commission finds that the Appendix to the March 30, 2018 Order should be amended to reflect the correct case number and the last rate step for the 5/8" x 3/4" Meter as set forth in the revised Appendix, attached to this Order.

IT IS THEREFORE ORDERED, *nunc pro tunc* that:

1. The Appendix of the Order of March 30, 2018, is stricken and is replaced by the revised Appendix attached to this Order.
2. All provisions of the Order of March 30, 2018, that are not in conflict with the terms of this Order shall remain in effect.
