



**REQUEST 1:**

Refer to Fleming-Mason's response to Commission Staff's February 6, 2017 Request for Information, Item 5, page 43 of 43.

- a. Confirm that International Paper is billed for electric service at East Kentucky Power Cooperative, Inc.'s ("EKPC") Rate Schedule G. If this cannot be confirmed, state the EKPC rate under which International Paper is billed.

**RESPONSE:** Fleming-Mason Energy confirms that electric service for International Paper is billed under EKPC's Rate Schedule G.

- b. If the Commission requires a change in EKPC's base fuel rate, EKPC is proposing a Schedule G energy rate of \$.038467. Fleming-Mason is proposing an energy rate to International Paper of \$.04047, a difference of \$.002003 from the EKPC rate. State whether this difference represents the retail mark-up billed by Fleming-Mason which is added to the EKPC rate. If not, explain the difference.

**RESPONSE:** This difference does represent the retail mark-up billed by Fleming-Mason.

- c. If the Commission requires a change in EKPC's base fuel rate, EKPC is proposing an International Paper steam energy rate of \$4.318/MMBtu. Fleming-Mason is proposing an International Paper steam energy rate of \$4.554/MMBtu. Explain the difference between Fleming-Mason's and EKPC's proposed steam energy rate.

**RESPONSE:** This was an error on Fleming-Mason's response in Item 5, page 43 of 43. International Paper steam energy rate should be \$4.318/MMBtu, the same as EKPC. Attached is a corrected Item 5, page 43 of 43.
