**RESPONDENT'S MOTION TO CONVERT 5-31-17 HEARING TO  
A PRE-HEARING CONFERENCE AND OBTAIN NEW HEARING DATE**

Comes the Respondents, by counsel, and does hereby move the Court to convert the 5-31-17 hearing to a pre hearing conference and obtain a new hearing date. In support of this motion Respondents state as follows:

1. Basil Pollitt is the only Respondent knowledgeable as to matters at issue per the Commissions 3-15-17 Order. As previously indicated in Response to that Order Basil Pollitt is recovering from colon cancer. On 5-14-17 he was readmitted to Baptist East Hospital due to infection. The official diagnosis is colocutaneous fistula. He remained hospitalized through 5-19-17. He was released to his home where he is to convalesce until the condition is resolved. He is visited by a home health agency on a daily basis and is further attended by his wife. A chronology of his condition and treatment is set forth below:

- A. 12-18-16—diagnosed with colon cancer.
- B. 12-19-17—emergency surgery wherein 8 inches of the colon was removed. A temporary colostomy bag is installed. Pollitt is hospitalized for 7 days.
- C. Following surgery Pollitt is Incapacitated for approximately 45 days.
- D. 3-10-17—surgery at Baptist East Hospital where colostomy is reversed and bowel reconnected.

E. 3-16-17--released to home where he is attended by home health care on a daily basis.

F. 4-18-17--released from doctor's care.

G. Early May '17--began experiencing seepage of a clear liquid from incision.


H. 5-13-17--seepage turns reddish (blood) and brown.

I. 5-14-17--Presents to Baptist Hospital ER--wound is surgically flushed and de-brided. Pollitt remains at Baptist Hospital thru 5-19-17. He is quarantined during this time.

J. 5-19-17--Pollitt discharged home where he is seen by home healthcare on a daily basis. His mobility and activities are extremely limited.

Pollitt anticipates fully recovering from the complications arising out of the surgical treatment of his colon cancer. It will however require time. Pollitt has medical records to support the above summary which he is willing to present for an in camera inspection. He does not however want to place same in the administrative record.

2. Accordingly, Pollitt moves this honorable Commission to convert the 5-31-17 hearing to a pre hearing conference and schedule a new hearing date so that he might fully recover.
