

**MOTION FOR EXTENSION OF TIME**


Kentucky RSA #3 Cellular General Partnership d/b/a Bluegrass Cellular (“Kentucky RSA #3”), by counsel, hereby moves the Public Service Commission of the Commonwealth of Kentucky (the “Commission”) for an extension of time through and including Thursday, March 22, 2018, within which to file its comments, or otherwise respond, to the intra-agency memorandum filed by the Kentucky Public Service Commission (the “Commission”). As grounds for this motion, Kentucky RSA #3 states as follows.

Kentucky RSA #3 received notice of the intra-agency memorandum shortly before the close of business on Friday, March 16, 2018. The notice requested that Kentucky RSA #3 submit comments within five days of its receipt of the notice. Kentucky RSA #3 requires additional time to consult with its legal counsel and experts and further investigate the facts of this matter in order to sufficiently file its comments, or otherwise respond, to the intra-agency memorandum.

Additionally, Kentucky RSA #3 should be afforded this one day extension of time to file its comments because no parties will be prejudiced by the extension. On Wednesday, March 21, 2018, Kentucky RSA #3 emailed a copy of its comments to Commission Staff, Corey Biddle, and John Potts.

Therefore, Kentucky RSA #3 respectfully requests the Commission to grant its motion for an extension of time through and including Thursday, March 22, 2018, to file its comments, or otherwise respond, to the intra-agency memorandum.


