MOTION TO RECONSIDER


Comes now Citipower, LLC (“Citipower”), by counsel, and hereby moves the Kentucky Public Service Commission (“Commission”) to reconsider the October 27, 2017 Order entered in this case. In the October 27, 2017 Order there is no mention of rate case expenses. As part of the record of this case, Citipower filed rate case expense information and asked that rate case expense be amortized over a three year period. The total amount of rate expense to date, including the filing of this motion, is as follows:

Legal fees:	\$19,173.00
Costs (mileage, copies, CDs, etc.);	\$1752.11
<u>Publication costs (office supplies, extra postage, etc.)</u>	<u>\$619.62</u>
Total:	\$21,544.73

WHEREFORE, Citipower respectfully moves the Commission to reconsider its October 27, 2017 Order which omitted any mention of rate case expense and to include the total rate case expense amortized over a three year period and adjust the rates included in the Appendix to that Order accordingly.
