

Notice is hereby given that Madison County Utilities District has filed an application with the Public Service Commission ("PSC") to adjust its water rates as a result of an increase from its supplier, Richmond Utilities. The proposed effective date is July 1, 2017. The proposed changes are as follows:

The average bill for a customer using 455 cubic feet of water each month would increase 1% from \$25.81 to \$25.96 for an increase of \$.15 in the average customer's monthly bill.
