
NOTICE OF SATISFACTION OF COMPLAINT

WHEREAS, on or about May 30, 2017, Margaret Beaumont-Carver filed a formal complaint against Louisville Gas and Electric Company (“LG&E”) relating to her request to transfer an electric account currently in the name of Studio 550, LLC, which had an outstanding balance, into her personal name.

WHEREAS, on June 20, 2017, the Kentucky Public Service Commission (“Commission”) issued an Order directing LG&E to file a written response to the allegations contained Ms. Beaumont-Carver’s Complaint.

NOW THEREFORE, LG&E hereby files this Notice to inform the Commission that LG&E’s representatives have worked with Ms. Beaumont-Carver to resolve all issues related to her Complaint. Specifically, LG&E has transferred the account from Studio 550, LLC’s name into Ms. Beaumont-Carver’s name, and has accepted full payment of the outstanding balance by Affordable Energy. Because the Complaint has now been satisfied, LG&E respectfully requests that this case be dismissed from the Commission’s docket.


