### Let's Give Every Child a Strong Start

Children represent the Children represent the poorest age group in Amer-ica. According to data re-leased in September by the U.S. Census Bureau, more than 13.2 million children were living in poverty in 2016. That means, in the world's most developed na-tion, one out of every three people living in poverty is a child.

These kids are put at an These kids are put at an unfair disadvantage com-pared to their more well off peers when it comes to education. For example, by age 4, children in poverty are as much as 18 months behind in development as other children.

That's why we're grate ful for programs working in Kentucky to help give all kids, especially those from low-income families, a strong start in life.

Save the Children be Save the Children be-gan its work in the United States in Kentucky com-munities in 1932, providing support to schoolchildren during the Great Depres-sion. Today, the organiza-tion has a presence in 41 Kentucky. communities Kentucky communities, serving nearly 18,000 chil-dren every year.

In October, we joined ac-tress and Save the Children Trustee Jennifer Gamer and Kentucky Senate Presi-dent Robert Stivers in Clay County to visit successful early learning programs in rural Eastern Kentucky and discuss local children 5 challenees at a community challenges at a community meeting.

During our visit, we met with Kelsey and Austin, the During our visit, we met with Kelsey and Austin, the parents of 16-month-old Ryker, a participant in Save the Children's Early Steps to School Success Program. This critical program as-

sists babies and young children with language, equips parents with the skills and knowledge needed to be the first and best teacher for their child, and develops strong connections between home and school.

Kelsey and Austin de-scribed their excitement for Ryker's future and spoke of their desire to give him the best start in life – and feel like they can with the help of Early Steps. They are ea-ger to learn more about how they can help prepare Ryker for a successful start to kin-dergarten.

We were encouraged by these parents' willingness to help their child succeed, and are working to make sure all children have the surport they need to be support they need to be suc-cessful.

Most of a child's brain is Most of a child's brain is developed by the time they are 5 years old, so it's criti-cal that all kids in the U.S. have access to high-quality early learning programs and childcare, which are key tools in breaking the cuele of source to cycle of poverty.

Our group also visited Manchester Elementary School, where many stu-dents receive free tutoring through 21st Century Com-munity Learning Centers-funded after-school literacy programs. As a result, a growing number of students are achieving distinguished or proficient ratings for litare achieving distinguished or proficient ratings for lit-eracy, like the little girl who proudly spoke with us about how she earned 100 percent on nearly all of her quizzes this year, and plans to con-tinue that streak during the pert of the school year. rest of the school year

Save the Children works in eight counties across Kentucky, and serves near-

ly 2,200 children in Clay County alone. Visiting the organization's critical pro-grams was an incredible opportunity to remind our-selves of what we know to be true – early childhood education transforms lives, especially for children liv-ing in poverty.

And while that is enough reason to provide further support, our economy also benefits from early child-hood programs. In fact, Nobel Prize-winning eco-nomist and University of Chicago professor James Heckman's most recent research shows that high-

quality early-childhood programs for disadvan-taged children more than pay for themselves, and can provide a 13 percent return on investment per year, per nt per year, pe child

All kids deserve an equal chance to succeed. That's why there is tremendous value in both federal and state investments in early learning and care programs.

# USDA issues Safety-Net payments to Ky. farmers

USDA Kentucky Farm Service Agency (FSA) Executive Director, Acting Robert W. Finch has announced that approximately 32,787 Kentucky farms that enrolled in safety-net programs established by the 2014 Farm Bill will receive financial assistance for the 2016 crop year. The programs, known as Agriculture Risk Coverage (ARC) and Price Loss Coverage (PLC), are designed to protect against unexpected drops in crop prices or revenues due to market downturns.

"These safety-net programs provide help when price and revenue fall below normal," said Finch "Payments to Barley, Canola, Corn, Dry Peas, Grain Sorghum, Oats, Soybeans and Wheat producers are helping

Producers in 100 Kentucky counties have experienced a significant drop in prices or revenues below the benchmark established by the ARC or PLC program and thus, will receive payments totaling \$90.5 million. Payments related to corn crops made up much of those payments. There were also payments for seven additional crops.

Statewide, over 27,930 farms participated in ARC-County and nearly 4,957 farms participated in PLC. More details on the price and yield information used to calculate the financing assistance from the safety-net programs is available on the FSA website at www.fsa.usda.gov/arc-plc and www.fsa.usda.gov/ky.
