ORDER

This matter is before the Commission on a motion filed by Muhlenberg County Water District (Muhlenberg District) to join Todd County Water District (Todd District) as a party to this proceeding. On July 20, 2017, William C. Hill (Mr. Hill) filed a formal complaint against Muhlenberg District alleging that Muhlenberg District failed to comply with terms of its tariff. Muhlenberg District filed its motion pursuant to Commission's Order of July 9, 2018, which directed Muhlenberg District to file a motion to join Todd District as a party to this matter. In support of its motion, Muhlenberg stated that Todd District's participation in this matter is necessary to ensure that Mr. Hill can obtain complete and appropriate relief.¹

The Commission finds that Todd District is likely to present issues or to develop facts that will assist the Commission in fully considering this matter and should be made a party to this proceeding.
