ORDER

This matter is before the Commission on a notice filed by Muhlenberg County Water District (Muhlenberg District) and William C. Hill (Mr. Hill) to notify the Commission of the Offer and Acceptance of Satisfaction executed by those parties. Muhlenberg District and Mr. Hill jointly move for the Commission to accept the Offer and Acceptance of Satisfaction as a resolution to this case and relieve Muhlenberg District of its obligation to respond to the requests for information propounded by Mr. Hill on July 16, 2018.

On July 26, 2017, Mr. Hill filed a formal complaint against Muhlenberg District alleging that Muhlenberg District failed to comply with the terms of its tariff. The parties in this matter attended an informal conference on February 7, 2018, and, most recently, the parties attended a formal conference before the Commission on July 5, 2018. By Order of July 17, 2018, Todd County Water District (Todd District) was joined as a party to this matter.

The Commission finds that the parties shall submit the settlement agreement in its final, executed form by September 10, 2018, for the Commission to review and make findings. Additionally, all deadlines to respond to requests for information or any requirements or deadlines regarding the October 16, 2018 hearing, should be held in abeyance pending the Commission's review of the settlement agreement.

IT IS THEREFORE ORDERED that:

1. The parties shall submit a copy of the settlement agreement in its final and executed form by September 10, 2018.
2. Todd District shall file a statement of its position on the settlement agreement by September 10, 2018.
3. Any deadlines that remain regarding outstanding requests for information or preparation for the hearing of October 16, 2018, are held in abeyance pending the Commission's review of the settlement agreement.
