

On behalf of the West McCracken County Water District, please find enclosed the original and ten copies of a Purchase Water Adjustment. The adjustment is in response to our supplier's (Paducah Water) decision to raise our wholesale rate from \$1.90/1,000 gallons to \$2.10/1,000 gallons October 1, 2017 which has already been approved by the PSC.
