APPLICATION

Duke Energy Kentucky, Inc. (Duke Energy Kentucky), pursuant to KRS 278.018(6) and 807 KAR 5:001 Section 14, hereby applies for approval of changes in certified service territory as agreed with Owen County Electric Cooperative (Owen Electric).

1. The full name and mailing address is: Duke Energy Kentucky, 139 E. Fourth Street, Cincinnati, Ohio 45202. The Company's local office in Kentucky is Duke Energy Envision Center, 4580 Olympic Boulevard, Erlanger, Kentucky 41018. Duke Energy Kentucky can also be reached at the electronic mail address of its counsel set forth below.

2. Duke Energy Kentucky is a utility engaged in the gas and electric business. Duke Energy Kentucky purchases, sells, stores and transports natural gas in Boone, Bracken, Campbell, Gallatin, Grant, Kenton and Pendleton Counties, Kentucky. Duke Energy Kentucky also generates electricity, which it distributes and sells in Boone, Campbell, Grant, Kenton and Pendleton Counties.

3. Pursuant to 807 KAR 5:001, Section 14(2), Duke Energy Kentucky states that it was originally incorporated in the Commonwealth of Kentucky on March 20, 1901, and attests that it is currently in good standing in said Commonwealth. Pursuant to 807 KAR 5:001, Section 14(2), a certified copy of Duke Energy Kentucky's certificate of good standing from the Kentucky Secretary of State and a certificate for the following assumed name: "Duke Energy." is on file with the Kentucky Secretary of State and on file with the Commission in Case No. 2017-00321.


4. Description of Changes in Service Territory: Duke Energy Kentucky and Owen Electric have individually agreed to the requested territorial change. The territorial boundary change requested for the Triple Crown Subdivision – lots 7 through 29, along Santos Drive and McCarron Lane, in Triple Crown Subdivision Section 32A in Boone County, Kentucky is a re-alignment due to proximity of the two utilities performing installation of utility service within the subdivisions. This requested change will serve the purposes of KRS 278.016 by avoiding unnecessary encumbering of the landscape and the duplication of facilities, as well as minimizing disputes between electric suppliers. The territorial maps provided constitute the entire agreement between Duke Energy Kentucky and Owen Electric.

5. Agreement and Maps: Attached as Application Exhibit 1 of this filing includes the summary list identifying Duke Energy Kentucky and Owen Electric personnel familiar with the specifics of the facilities available, the reason for the change and purposes served under KRS 278.016, and copies of the territorial (quadrant) map, detail map, and agreement signed by both parties for the properties involved.

WHEREFORE, Duke Energy Kentucky hereby requests, pursuant to KRS 278.018, that the Commission enter its order approving the service territory changes and Agreements allocating these electric services as agreed to by the parties. Due to size and scale of the maps, Duke Energy Kentucky requests the Commission to deviate from 807 KAR 5:001 Section 7 and permit Duke Energy Kentucky to file only two complete sets of maps.




