## **RESPONSE:**

Columbia is forecasting 2018 Account 887 O&M to equal the Account 887 budget amount following Case No. 2016-00162, therefore, no O&M savings are projected. Should there be an actual savings, it would be credited as part of the Balancing Adjustment in March 2019.

As cast iron and unprotected steel pipe are replaced in the AMRP, it was contemplated that, in time, there would be savings in Account 887. It was also recognized that new leaks would continue to be found and leak severities could change during the duration of the program and would be increases to cost. This activity is expected to continue in 2018 which is why \$0 savings are projected in 2018. Columbia's AMRP provides for the return of savings in Account 887 but does not provide recovery for increases in Account 887 cost.

Provide a comparison of the original estimate of the projects included in the

AMRP with those completed and with those yet to be completed.

**RESPONSE:** 

In 2008, Columbia estimated the then total cost of projects associated with the 30

year Accelerated Main Replacement Program to be \$210 million. By the end of

2017, Columbia will have spent approximately \$127 million and retired 138 miles

of bare steel and cast iron pipe. Columbia has 387 miles of pipe yet to be

completed as part of the program. The total cost of the projects yet to be

completed requires a study that has not been performed. Columbia anticipates

having all cast iron removed from the system by December of 2022 and the

remainder of the bare steel eliminated by the end of 2037.
