ORDER

A hearing on the proposed adjustment of the wholesale water service rates of Lebanon Water Works was held at the offices of the Kentucky Public Service Commission, 211 Sower Boulevard, Frankfort, Kentucky, on June 20, 2018. At the conclusion of the testimony, counsel for the respective parties and staff counsel advised that post hearing data requests were needed to complete portions of the evidentiary record and counsel for the respective parties expressed the desire to file post hearing briefs.

IT IS THEREFORE ORDERED that:

1. Post hearing data requests shall be filed in the record on or before Thursday, June 21, 2018.
2. Responses to post hearing data requests shall be filed in the record on or before Wednesday, June 27, 2018.
3. Lebanon Water Works shall file its post hearing brief on or before Friday, June 29, 2018.


4. Marion County Water District shall file its Post hearing brief on or before Tuesday, July 3, 2018.
