ORDER

Kentucky Rural Water Association ("KRWA") has applied for accreditation and approval of three training programs held on October 10, 2017, in Morehead, Kentucky; on October 12, 2017, in Hawesville, Kentucky; and on October 19, 2017, in Draffenville, Kentucky. Each of the programs lasted two hours.

The program in Morehead, Kentucky consisted of a presentation relating to the use and proper maintenance of valves. The programs in Hawesville and Draffenville, Kentucky were similar and consisted of a presentation relating to leak detection.

Having reviewed KRWA's application, the Commission finds that the presentations at the trainings will enhance a water district commissioner's understanding of their responsibilities and duties. The Commission accredits the program relating to the use and proper maintenance of valves and the presentation relating to leak detection, and approves each event for up to two credit hours of water district management training.

The Commission notes that, while it has approved this program for water district commissioner training that has already occurred, the Commission, in Case No. 2018-

00085¹, has established new guidelines for receiving accreditation for water district commissioner training. All future applications for accreditation for water district commissioner training must conform to the requirements of Case No. 2018-00085 or the Commission will not approve the application.

IT IS THEREFORE ORDERED that:

- The presentation at Morehead, Kentucky is accredited and approved for a maximum of two credit hours of water district management training.
- 2. The presentations at Hawesville and Draffenville, Kentucky, are accredited and approved for a maximum of two credit hours of water district management training.
- 3. KRWA shall retain a record of all water district commissioners attending the accredited and approved presentations.
 - 4. Within 30 days of this Order, KRWA shall file with the Commission:
- a. A sworn statement attesting that the accredited instruction was performed;
- b. A description of any changes in the presenters or the proposed curriculum that occurred after KRWA's application:
- c. The name of each attending water district commissioner, their water district, and the number of hours they attended;
- d. A copy of any written material given to water commissioners attending the presentations; and
