COMMISSION STAFF'S FIRST REQUEST FOR INFORMATION TO ROGER W. PARRY

Roger W. Parry, Complainant ("Mr. Parry") pursuant to 807 KAR 5:001, is to file with the Commission, with a copy served on Kentucky-American Water the original with six copies of the following information. The information requested herein is due within 14 days of the date of this request. Responses to requests for information in paper medium shall be appropriately bound, tabbed, and indexed. Each response shall include the name of the witness responsible for responding to the questions related to the information provided.

Each response shall be answered under oath or, for representatives of a public or private corporation or a partnership or association or a governmental agency, be accompanied by a signed certification of the preparer or the person supervising the preparation of the response on behalf of the entity that the response is true and accurate to the best of that person's knowledge, information, and belief formed after a reasonable inquiry.

Mr. Parry shall make timely amendment to any prior response if it obtains information which indicates that the response was incorrect when made or, though correct when made, is now incorrect in any material respect. For any request to which Mr. Parry fails or refuses to furnish all or part of the requested information, he shall provide a written explanation of the specific grounds for its failure to completely and precisely respond.

Careful attention shall be given to copied material to ensure that it is legible. When the requested information has been previously provided in this proceeding in the requested format, reference may be made to the specific location of that information in responding to this request. When filing a paper containing personal information, Joint Applicants shall, in accordance with 807 KAR 5:001, Section 4(10), encrypt or redact the paper so that the personal information cannot be read.

Provide a copy of any report or other documentation received from Right
On Leak and Line Inspection confirming there were no leaks in your water system.

2. Explain what portion of the water line was examined by Right on Leak and Line Inspection. Specify whether they examined the water line inside the house, outside the house, or both.

3. Explain any repair work that has been done to any indoor plumbing in the residence including but not limited to, toilets, sinks, washing machines, or faucets. Specify the kind of work done, the date of the work, and any receipts for the work. Give contact information for the company or individual who performed the work.
