ORDER

On December 5, 2017, Boone County Water District (“Boone County”) applied for approval to adjust its rates pursuant to the purchased water adjustment procedure.¹

The Commission, having reviewed the record and being sufficiently advised, finds that:

1. Boone County purchases water from the Boone-Florence Water Commission (“Boone-Florence”).

2. Boone-Florence notified Boone County that its wholesale rate would increase from \$3.1800 per 1,000 gallons to \$3.2754 per 1,000 gallons effective January 1, 2017. Boone County proposes to increase the water rates to its customers effective January 1, 2018, to reflect the increased cost of purchased water from Boone-Florence.

3. Boone County proposed a purchased water adjustment factor of \$0.11 per 1,000 gallons.

4. During the 12 months ended August 31, 2017, Boone County purchased 2,734,944,564 gallons of water from Boone-Florence. During the same period, Boone County sold 2,479,651,183 gallons of water. The increase in the cost of purchased

water is \$260,913.42, resulting in a purchased water adjustment factor of \$0.11 per 1,000 gallons.

5. The purchased water adjustment factor of \$0.11 per 1,000 gallons, as calculated in Appendix A to this Order, is fair, just, and reasonable and should be approved.

6. Boone County's proposed rates, as set forth in Appendix B to this Order, are fair, just, and reasonable and should be approved for water service rendered by Boone County on and after January 1, 2018.


IT IS THEREFORE ORDERED that:

1. The purchased water adjustment factor of \$0.11 per 1,000 gallons is approved.

2. Boone County's proposed rates as set forth in Appendix B to this Order are approved for water service rendered by Boone County on and after January 1, 2018.

3. Within 20 days of the date of this Order, Boone County shall file with the Commission, using the Commission's electronic Tariff Filing System, revised tariff sheets showing the rates approved herein.
