



Irvine Municipal Utilities

At a regular scheduled communication of the Irvine Municipal Utilities Commission, vested by ordinance, a motion was made, and second with all attending members in agreement to accept the United States Labor Consumer Price Index increase of 3.0% for the calendar year 2017, in accordance with the City of Irvine's ordinance #31.03. The commission found the adjustment necessary, being charged to ensure that the revenues of the utility are sufficient to cover all debt service, management, control, maintenance, and operation on the combined and consolidated water system and wastewater systems. This rate adjustment, per ordinance, shall take place March 1st, 2018. Customers will not see the increase until the May 1st, 2018 billing.

On February 27, 2018 at 9:00 a.m., or as soon thereafter as the case can be heard, the Kentucky Public Service Commission will conduct a hearing in Case No. 2017-00467 at its offices at 211 Sower Boulevard, Frankfort Kentucky, to consider whether Estill County Water District No. 1 unlawfully issued evidences of indebtedness without prior Commission authorization, whether the members of Estill County Water District No. 1's Board of Commissioners aided and abetted such unlawful issuances, and whether Estill County Water District No. 1 and the members of its Board of Commissioners should be subject to penalty for these alleged actions. This hearing will be streamed live and may be viewed on the Kentucky Public Service Commission's website at psc.ky.gov.
