Irvine Municipal Utilities

At a regular scheduled communication of the Irvine Municipal Utilities Commission, vested by ordinance, a motion was made, and second with all attending members in agreement to accept the United States Labor Consumer Price Index increase of 3,0% for the calendar year 2017, in accordance with the City of Irvine's ordinance #31.03. The commission found the adjustment necessary, being charged to ensure that the revenues of the utility are sufficient to cover all debt service, management, control, maintenance, and operation on the combined and consolidated water system and wastewater systems. This rate adjustment, per ordinance, shall take place March 1st, 2018. Customers will not see the increase until the May 1st, 2018 billing.
