**JOINT MOTION FOR
TELEPHONIC CONFERENCE WITH COMMISSION STAFF**

In accordance with 807 KAR 5:001, Section 9(4), Respondent Jonathan Creek Water District (“District”), together with the individual Respondents, Jimmie Tubbs, Barry Hill, Josh Medley, Mark Holt and Kara Wilson, by and through counsel, move the Public Service Commission (“Commission”) to convene a telephonic conference between these Respondents, their counsel and the Commission’s Staff for the purpose of considering the possibility of settlement, the simplification or clarification of issues or any other matter that may aid in the handling and disposition of the case.

The Respondents believe that a Staff conference may be productive and a settlement is possible. The Respondents believe that exploring the prospects of settlement with the Staff will promote efficiency by reducing the District’s costs and expenses, which may be passed to its customers, and saving the time of the parties and the Commission, if a settlement is reached, without jeopardizing the purpose and import of the Commission’s Order herein. The District is located in Marshall County, Kentucky, nearly four (4) hours from the Commission’s Office. Thus, the District requests that the Commission permit a

telephonic conference, if it is inclined to convene a conference, to save the Respondents the time of traveling to and from the Commission's office.

WHEREFORE, the Respondents request the Commission to enter an Order convening a telephonic conference between the Respondents and the Commission's Staff pursuant to KAR 5:001, Section 9(4).
