FISCAL MANAGEMENT

Borrowing Money

PUBLIC SERVICE COMMISSION AUTHORIZATION

The District must obtain the written authorization of the Public Service Commission before issuing any securities or evidences of indebtedness, or assuming any obligation or liability in respect to the securities or evidences of indebtedness of any other person, in accordance with the provisions of KRS 278.300.

EXCEPTION(S)

The District may issue notes for proper purposes and not in violation of law, that are payable at periods of not more than two (2) years from the date thereof, or to like notes, payable at a period of not more than two (2) years from date thereof, that are issued to pay or refund in whole or in part any such notes, or to renewals of such notes from time to time, not exceeding in the aggregate six (6) years from the date of the issue of the original notes so renewed or refunded, without the prior written authorization of the Public Service Commission, in accordance with KRS 278.300.

LEGAL COUNSEL REVIEW

Notwithstanding, prior to issuing any securities or evidences of indebtedness, or assuming any obligation or liability in respect to the securities or evidences of indebtedness of any other person, the District must consult with legal counsel to determine if the District must obtain the Public Service Commission's prior approval to issue the securities, borrow the money, or assume the obligations or liabilities of the other person.

REVIEW

The Board of Commissioners shall conduct an annual review of this policy at its October meeting.
