RE: Informal Conference of January 17, 2018

Pursuant to an Order issued on January 12, 2018, an informal conference ("IC") was conducted on January 17, 2018. Attached is a copy of the attendance roster.

The purpose of the IC was to discuss Offers of Satisfaction filed by Kentucky Utilities Company ("KU") and Louisville Gas and Electric Company ("LG&E") (jointly, "KU/LG&E") and the possible resolution of issues as to KU and LG&E only. The parties inquired about pending motions to bifurcate this proceeding into four utility-specific proceedings. Commission Staff indicated an Order would be entered shortly. After a brief discussion, representatives of Kentucky Power Company and Duke Energy Kentucky, Inc. were excused.

After a period of discussion, LG&E/KU, Kentucky Industrial Utility Customers, Inc., and the Attorney General agreed to continue the discussion of potential settlement of the issues on Monday, January 22, 2018, at 1:30 p.m. (Eastern).

There being no further discussion, the IC was then adjourned.
