I want to object to the emergency rate increase requested by the Martin County Water District on the following grounds: (1) The water-rate loss for the district in 2002 was 50 percent. For last year it was nearly 65 percent. There has been no progress in the last 16 years. I believe this is significant for the following reasons in that I suspect they don't really want to resolve their water rate loss. In 2002 the water district hired Kentucky American Water to get their system into shape. I believe KAW would have found these leaks and resolved the problem. They weren't there that long. When Martin County Judge/Executive Kelly was elected he dissolved the water board, appointed members and broke the contract with KAW. In an internal memo I obtained, I believe from PSC files, KAW officials discussed the water loss with MCWD staff and employees who attributed the loss to unmetered taps and bypasses. Since they were booted out, this suspicion was never addressed.

During testimony by Joe Burns from the Kentucky Rural Water Association last year in the current ongoing series of hearings in the current investigation, Burns recommended an "amnesty program" for anyone with water service that might be hooked up illegally. The water district has never acted on this recommendation. I wonder why?

It isn't fair for customers for those hooked up illegally to bear the burden, and I suspect the only way to get to the bottom of this is some kind of investigation that entails looking at all customers, residential and commercial, to make an assessment of where this loss is going. The Bible says love covers multitude of sins. It could be that a consistently high water rate loss -- ranging from 50 to 65 percent in the last 16 years -- can cover a multitude of theft. Since the water district, by its actions, has not attempted to do this, It's time that another agency equipped to this step in.
