MOTION FOR CONFIDENTIAL TREATMENT

Comes Applicant Sentra Resources LLC, by counsel, and in support of its Motion for the designation of the Personal Financial Statements of Wesley Dustin Cleary, Dan Bryant and Randy Darren Cleary as confidential material pursuant to 807 Kentucky Administrative Regulation Chapter 5:001, Section 13, states as follows:

1. The Commission Staff's Information Request No. 9 stated "provide current personal financial statements for Wesley Dustin Cleary, Dan Bryant and Randy Darren Cleary." In response to this interrogatory, Wesley Dustin Cleary, Dan Bryant, and Randy Darren Cleary and Dawn Cleary, husband and wife, are each submitting their Personal Financial Statements.

2. 807 Kentucky Administrative Regulation Chapter 5:001, Section 13, governs the treatment of confidential information filed with the Public Service Commission, and provides that documents and information exempt from disclosure under KRS 61.878 can be classified by the Commission as confidential.


3. KRS 61.878(1)(a) exempts from open records review "Public records containing information of a personal nature where the public disclosure thereof would constitute a clearly unwarranted invasion of personal privacy." The Personal Financial Statements of Wesley Dustin

Cleary, Dan Bryant and Randy Darren Cleary and Dawn Cleary, husband and wife, are each comprised totally of information of a personal nature, the public disclosure of which would constitute a clearly unwarranted invasion of privacy. There is no valid reason that any individuals or entities other than the Public Service Commission and its Staff should be provided with information concerning the personal assets and liabilities of Wesley Dustin Cleary, Dan Bryant and Randy Darren Cleary and Dawn Cleary, husband and wife. These Personal Financial Statements are also subject to confidential treatment based upon KRS 61.878(1)(c) because this confidential information would give the competitors of Wesley Dustin Cleary, Dan Bryant and Randy Darren Cleary an unfair commercial advantage if the information in the Personal Financial Statements were openly disclosed. Finally, this information should be treated as confidential pursuant to KRS 61.878(1)(c)(2) as it is confidential information required to be disclosed to the Public Service Commission, is information generally recognized as confidential and it will be reviewed by the Public Service Commission in determining whether or not to approve the Joint Application to transfer the shares of stock of Sentra Corporation Inc., to Sentra Resources, LLC.

4. Due to the extremely private nature of the information contained in the Personal Financial Statements, the Petitioners request that the confidential information contained in the Personal Financial Statements remain confidential for as long as they are maintained by the Public Service Commission.

5. Pursuant to 807 KAR Chapter 5:001, Section 13, copies of the Personal Financial Statements are attached with those portions redacted for which confidentiality is sought. Attached to the original of the Motion for Confidential Treatment, in a separate sealed envelope marked Confidential, is one copy of the Personal Financial Statements which identifies by highlighting with transparent ink those portions that unless redacted would disclose confidential material.
