COMMISSION STAFF'S SECOND REQUEST FOR INFORMATION TO SENTRA CORPORATION, BLUE RIDGE MOUNTAIN RESOURCES INC. AND SENTRA RESOURCES LLC

Sentra Corporation ("Sentra"), Blue Ridge Mountain Resources, Inc. ("BRMR"), and Sentra Resources LLC ("Sentra Resources") (collectively "Joint Applicants") pursuant to 807 KAR 5:001, are to file with the Commission the original and six copies of the following information, with a copy to all parties of record. The information requested herein is due no later than May 15, 2018. Responses to requests for information in paper medium shall be appropriately bound, tabbed, and indexed. Each response shall include the name of the witness responsible for responding to the questions related to the information provided.

Each response shall be answered under oath or, for representatives of a public or private corporation or a partnership or association or a governmental agency, be accompanied by a signed certification of the preparer or person supervising the preparation of the response on behalf of the entity that the response is true and accurate to the best of that person's knowledge, information, and belief formed after a reasonable inquiry.

Joint Applicants shall make timely amendments to any prior response if they obtain information which indicates that the response was incorrect when made or, though correct when made, is now incorrect in any material respect. For any request to which Joint Applicants fail or refuse to furnish all or part of the requested information, they shall provide a written explanation of the specific grounds for its failure to completely and precisely respond.

Careful attention should be given to copied material to ensure that it is legible. When the requested information has been previously provided in this proceeding in the requested format, reference may be made to the specific location of that information in responding to this request. When filing a document containing personal information, Joint Applicants shall, in accordance with 807 KAR 5:001, Section 4(10), encrypt or redact the paper so that personal information cannot be read.

- Provide the journal entry or entries Sentra will make to record the proposed ownership transfer.
- Provide the fair market value of the assets to be acquired by Sentra Resources.
- 3. Refer to Sentra's response to Commission Staff's First Request for Information ("Staff's First Request"), Item 10. Provide the current status of Sentra Resources' discussions to obtain liability insurance for Sentra.
 - 4. Refer to Sentra's response to Staff's First Request, Items 11 and 12.
- a. State whether Sentra's current gas supply contract with Greystone LLC will remain in effect after the proposed transaction. Provide any relevant documentation.

b. State whether Sentra Resources has performed any analysis of

available gas supply other than Sentra's current supply. Provide any relevant

documentation of this analysis.

5. Refer to Sentra's response to Staff's First Request, Items 16.c., 16.d., and

18.a., regarding Cleary Construction, Inc., Rock Solutions LLC, and Cleary Group LLC.

State whether Sentra Resources has developed a cost allocation manual to allocate

expenses from its unregulated affiliate to Sentra. If so, provide a copy of the cost

allocation manual. If not, explain why not.

6. Refer to Sentra's response to Staff's First Request, Item 18.a. The

response states, "Sentra Resources will not be subject to regulation by the Commission."

The response also states, in relevant part, "The members of Sentra Resources, which is

regulated by the Public Service Commission" Confirm which statement is the

statement Joint Applicants intended to make.

7. Refer to Sentra's Response to Staff's First Request, Item 33, Attachment 1

and the Application, page 3, which states "Sentra Corporation's cash flow has been

sufficient to permit the utility to provide reasonable service." Reconcile this statement

and the response provided.
