Comes now Inter-County Energy Cooperative Corporation (“Inter-County”), by counsel, pursuant to KRS 278.180, 807 KAR 5:001 Sections 14 and 16, and other applicable law, and for its Application requesting a general adjustment of existing rates, respectfully states as follows:

1. Inter-County is a not-for-profit, member-owned, rural electric distribution cooperative organized under KRS Chapter 279. Inter-County is engaged in the business of distributing retail electric power to approximately 26,000 members in the Kentucky counties of Boyle, Casey, Garrard, Larue, Lincoln, Madison, Marion, Mercer, Nelson, Rockcastle, Taylor and Washington Counties. It maintains 3,985 miles of distribution lines and has a member density of approximately 6.6 members per mile.
