

LEGAL NOTICE REGARDING THE MARION COUNTY WATER DISTRICT

Notice is hereby given that because of an increase in the cost of water purchased from the Lebanon Water Works Company, the Marion County Water District will increase its rates for services effective April 16, 2018. An application requesting the proposed rates was filed with the Kentucky Public Service Commission on April 20, 2018 to increase rates as follows:

As noted above, based on the increased cost of water from the Lebanon Water Works Company all rates will increase \$1.33 per 1,000 gallons. The monthly bill for an average residential customer using 5,343 gallons of water each month will increase from \$37.64 to \$44.74. This is an increase of \$7.10 or 18.86%.

The charges/rates contained in this notice are the charges/rates proposed by the Marion County Water District. However, the Public Service Commission may order charges/rates to be charged that differ from these proposed charges/rates. Such action may result in charges/rates for consumers other than the charges/rates detailed in this notice.
