In Paragraph 18 of Big Rivers Electric Corporation's application in the above-referenced matter, Big Rivers requests a finding from the Public Service Commission "authorizing Big Rivers to continue to operate Station Two under the terms of the Contracts for a period up to and including May 31, 2019, if Henderson desires that Big Rivers do so."
