Pursuant to the discussions at the oral argument held before the Kentucky Public Service Commission ("Commission") on July 25, 2018 in this proceeding, Kentucky Industrial Utility Customers, Inc. ("KIUC") submits this letter to express its non-opposition to Big Rivers Electric Corporation's ("Big Rivers" or "Company") request for a declaratory order from the Commission stating that the Company's contracts with the City of Henderson, Kentucky and the City of Henderson Utility Commission which relate to the operation of the Station Two generating units ("Contracts") are no longer economic and are therefore terminated. KIUC also does not object to Big Rivers' request to continue operating the Station Two units for up to 13 months, if necessary, to allow Henderson time to make alternative power supply arrangements. However, KIUC continues to object to Big Rivers' request for authority to establish a regulatory asset to defer certain expenses the Company will incur as a result of the termination of the Contracts while at the same time retaining all cost savings associated with terminating the Contracts.


