



3. Peoples' notice sets out no Refund Adjustment.
4. Peoples' notice sets out a current quarter Actual Cost Adjustment ("ACA") of \$.8460 per Mcf. Peoples' total ACA is \$.8323 per Mcf, which is an increase of \$.6001 per Mcf from the previous total ACA of \$.2322 per Mcf.
5. Peoples' notice sets out a current quarter Balance Adjustment ("BA") of \$.0225 per Mcf. Peoples' total BA is \$.0756 per Mcf, which is an increase of \$.1539 per Mcf from the previous total BA of (\$.0783) per Mcf.
6. Peoples' GCR rate is \$5.6344 per Mcf, which is an increase of \$1.4626 per Mcf from its previous rate of \$4.1718 per Mcf.
7. The rate as proposed by Peoples and set forth in the Appendix to this Order is fair, just, and reasonable, and should be approved for final meter readings by Peoples on and after August 1, 2018.


IT IS THEREFORE ORDERED that:
